- ✓ Conduct intellectual property due diligence (portfolio analysis, IP ownership, IP-related agreements) in collaboration with legal and business development teams for potential collaborations, partnerships, and licensing opportunities.
- ✓ Work closely with AUROBAC's Head of BD to assist in transactions related to licensing, collaborations, and acquisitions: deal models, contract review and drafting, negotiations.

Manage AUROBAC's Intellectual Property Portfolio

- ✓ Manage AUROBAC's patent portfolio in close collaboration with its Patent Law Firms: drafting and filing of patent applications in close collaboration with scientific inventors from the company, prosecuting, monitoring and paying patent maintenance fees.
